Welcome to the Minot Curling Club. Here are the fees for the season. We appreciate your attention to this as soon as possible. Make sure you sign the insurance liability release on the reverse side also. Deadline for dues- Jan 6, 2017

*You will note there are two levels for membership in each category. Please consider the full USCA membership. If you choose this level, your will be supporting the USCA in their programs for competition and promotion of curling ( including the Olympic teams). You will also receive the Curling News, be eligible to compete in events outside of our club events such as playdowns, out of town bonspiels, etc. The extra \$35 per person goes directly to the USCA for their programs. This will also include the use of a locker in our clubroom.*

*In addition, you will note the \$10 insurance fee per member. This fee goes to our insurance provider for liability protection. This is required for every member, in addition to their signature on the liability release on the reverse side.*

**PARTICIPANT RELEASE**

In consideration of being allowed access to the Minot Curling Club as a participant in any curling activity in club, I, the undersigned, for myself and my estate, successors, heirs, beneficiaries, administrators, trustees, representatives, and attorneys do hereby remise, release, acquit, and forever discharge the Minot Curling Club, a North Dakota Curling Association(NDCA) member of the United States Curling Association (“USCA”) the respective successors and assigns of each of the Club, USCA, and NDCA; and (v) the respective employees, officers, and directors, but only while acting in their capacity as such, of each of the Club, USCA, and NDCA (collectively, the “Releasees”) from any and all actions, causes of action, claims, demands, and liabilities, both in law and equity for damages and any court costs and legal expenses and fees associated therewith in respect of physical, mental, and bodily injury occurring to me while participating in any curling activity in the curling club prior to the Expiration Date (as defined below); provided, however, that in the event such injury was caused, in whole or in part, by the willful, intentional, reckless, or grossly negligent action or failure to take action of any Releasee(s), such Releasee(s) shall not be so remised, released, acquitted, or discharged hereby; and provided, further, that nothing herein shall be deemed to limit or exclude any action, cause of action, claim, demand, liability, payment, reimbursement, other benefit, or any court costs or legal expenses and fees that I or my estate, successors, heirs, beneficiaries, administrators, trustees, representatives, or attorneys might have or seek against (a) the Club’s “Participant Medical Accident” insurance coverage, (b) any other participant (including persons referenced in clause (v) above who are participants) participating in any curling activity in the Ice House, or (c) against any other person or entity other than a Releasee.

The curling club shall mean the single room containing 4-6 sheets of ice in which the sport of curling is played, the club room area and the parking nearby the building located at ND State Fairgrounds, 2005 E Burdick Expressway, Minot, ND. The expiration date shall mean the date which is one (1) calendar year after the date this Release is executed below.

I certify that I am at least eighteen (18) years of age and have the legal capacity to execute this Participant Release on my own behalf.

I hereby revoke any and all releases of liability, waivers, and indemnifications previously executed by me in favor of any of the Releasees.

BY SIGNING BELOW, I UNDERSTAND THAT I AM WAIVING SIGNIFICANT RIGHTS. I UNDERSTAND THE MEANING OF THIS PARTICIPANT RELEASE AND THE RIGHTS I AM WAIVING. NOTWITHSTANDING THE FOREGOING, I HAVE CHOSEN, OF MY OWN FREE WILL, TO EXECUTE THIS PARTICIPANT RELEASE.**
